### Unlimited Premium Package

Mpxthy Muziq and Licensee agree to the following terms and conditions:

The Licensee is entitled to **unlimited** audio streams on all streaming platforms (**Spotify, Apple Music, and more**). Licensee shall have the worldwide, non-exclusive right to sell **unlimited** hard copies (**CDs**), **broadcast on the radio unlimited times**, and earn an **unlimited** amount of money performing publicly using the song they create with this MP3 or WAV file instrumental produced by Mpxthy Muziq. Licensee may also use the song they create with this MP3 or WAV file instrumental in any profitable projects. **This MP3 or WAV file instrumental must be combined with lyrics**. Licensee shall have the worldwide, non-exclusive right to synchronize this MP3 or WAV file instrumental with visual media (**movies, TV, videos, video games, websites**) an **unlimited amount of times for for-profit projects**. Licensee may also synchronize this MP3 or WAV file instrumental in **unlimited music videos**. **Licensee agrees to pay Mpxthy Muziq the one-time purchasing fee in the amount of \$75. No royalties will ever be owed. In all Projects in which this MP3 or WAV file instrumental is used, Licensee shall give credit in substantially one of the following formats:**

“Produced by **Mpxthy Muziq**”

“Original Beat by **Mpxthy Muziq**” (If changes to the instrumental are made such as rearranging or adding)

Tip and Tricks to getting paid off of your music

- Get an LLC (If you already have an LLC under another business then file for a fictitious name)
  - Sign up for DistroKid
  - Sign up for an Ascap or BMI
  - Sign up for SoundExchange
  - Sign up for a SongTrust
- READ ALL CONTRACTS BEFORE REGISTERING SONG(S) UNLESS YOU OWN 100% OF YOUR WORK

### **Do's and Don'ts**

Artist cannot remix the instrumental produced by **Mpxthy Muziq**

Artist cannot resell the instrumental produced by **Mpxthy Muziq**

Artist cannot sample the instrumental produced by **Mpxthy Muziq**

Artist can rearrange the instrumental to their liking but must credit the Producer (**Mpxthy Muziq**)  
when releasing the song

When uploading to streaming platforms artist must feature **Mpxthy Muziq** to their song so it's  
easier to find who produced it.

**Songwriting/Publishing Shares are required**

**Artist - 50% writers**

**Producer - 50% writers**
